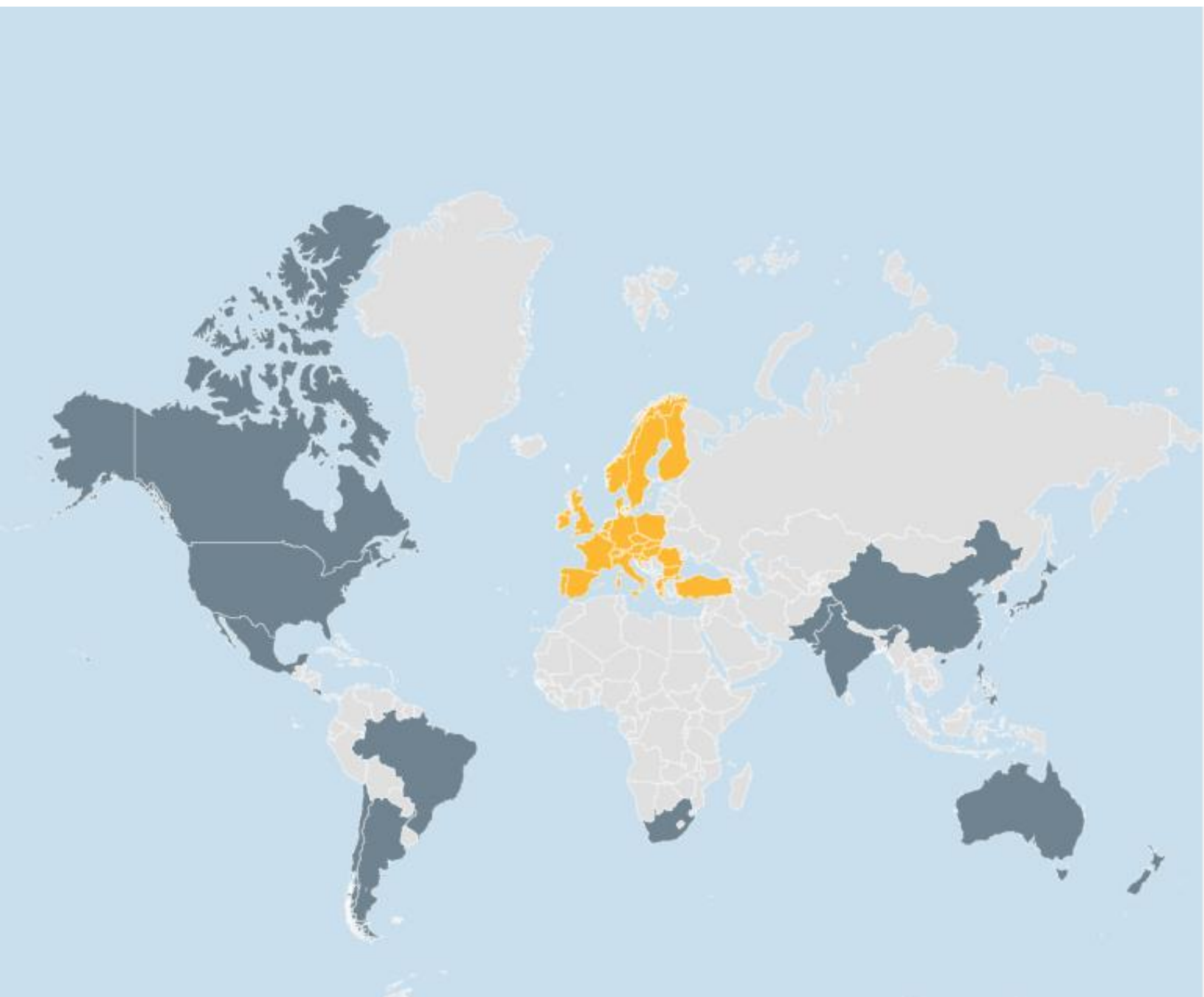
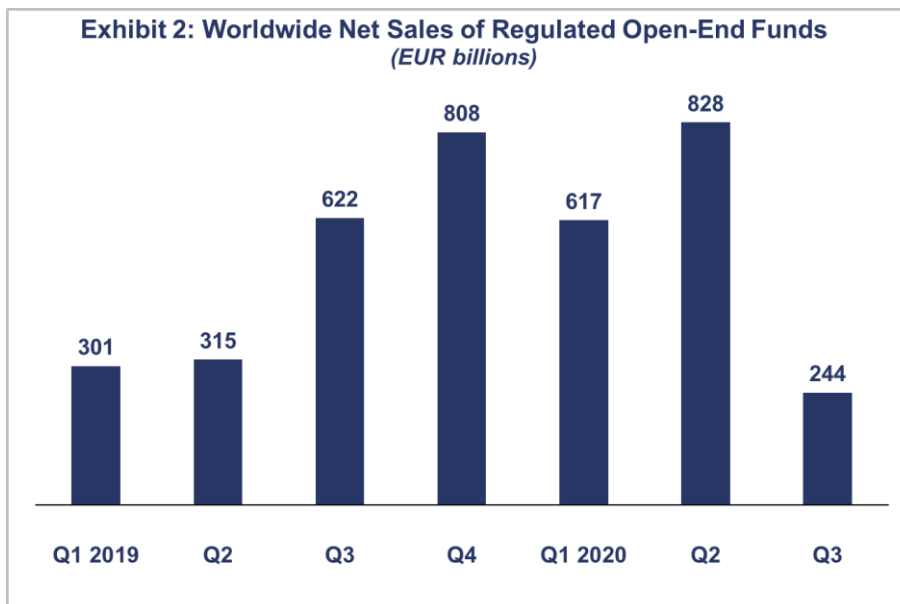
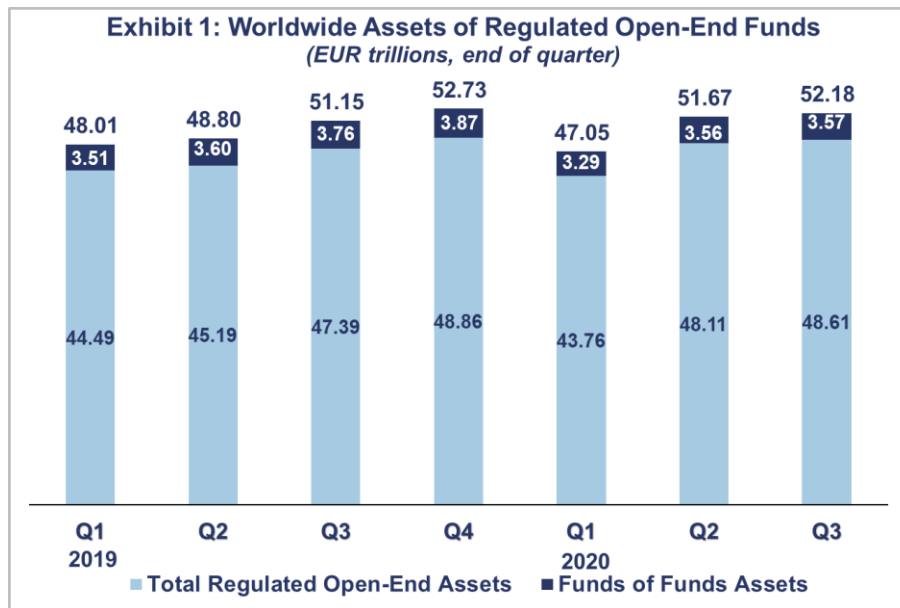


Worldwide Regulated Open-ended Fund Assets and Flows

Trends in the Third Quarter of 2020



Brussels, December 21, 2020 – Worldwide regulated open-ended fund assets increased by 1 percent to EUR 52.2 trillion in Q3 2020.¹ Worldwide net cash flow to all funds amounted to EUR 244 billion, compared to EUR 828 billion in Q2 2020.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Measured in U.S. dollars, worldwide investment fund net assets increased to USD 61.1 trillion at the end of Q3 2020. This represented an increase of 5.6 percent. The smaller asset growth measured against the euro reflects the depreciation of the dollar vis-à-vis the euro during Q3 2020. The following two graphs compare the net asset growth in the seven largest countries/regions.

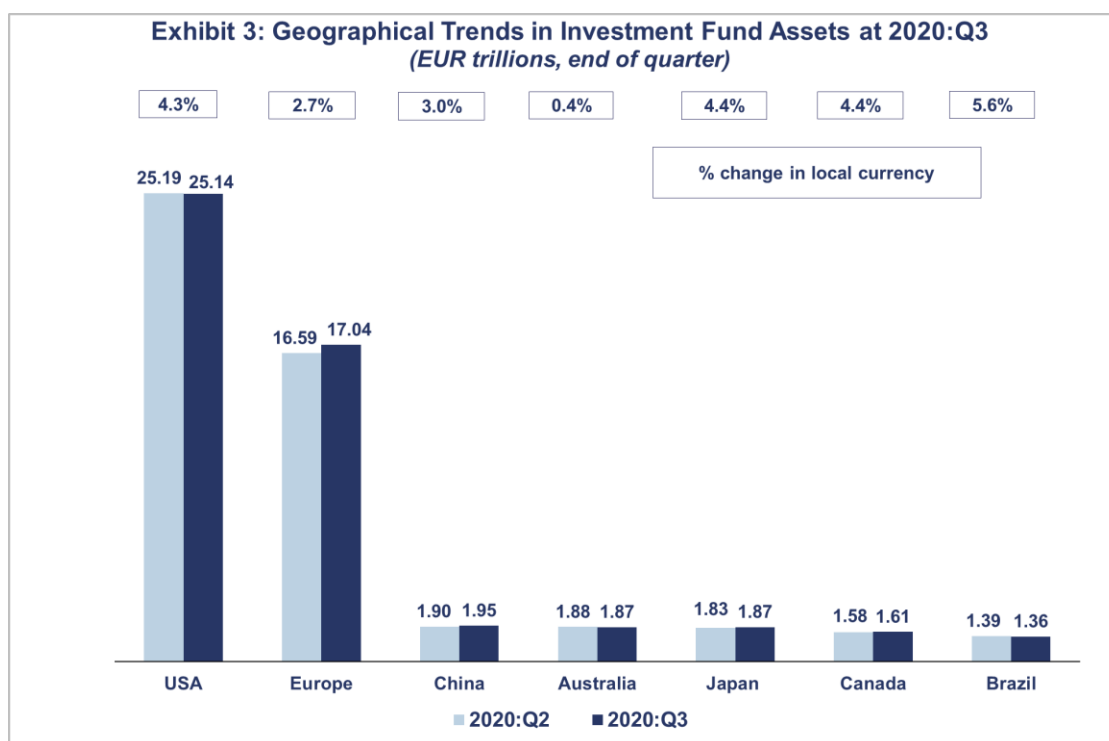

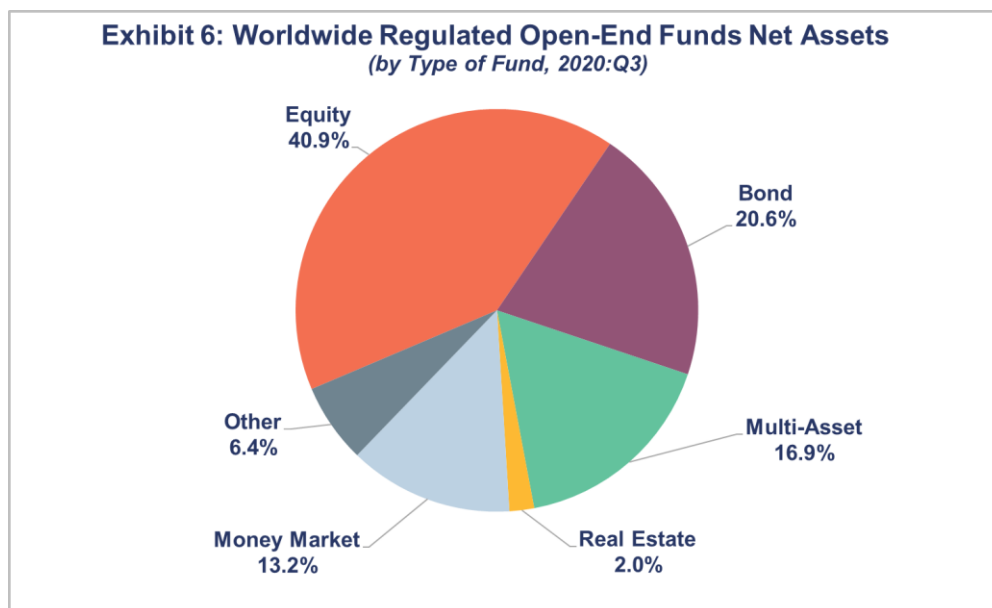
On a euro-denominated basis, worldwide equity fund assets increased by 2.9 percent to 21.3 trillion at the end of Q3 2020. Bond fund assets increased by 0.4 percent to EUR 10.8 trillion. Multi-asset funds increased by 2.1 percent to EUR 8.8 trillion. Money market funds decreased by 5.4 percent to EUR 6.9 trillion.

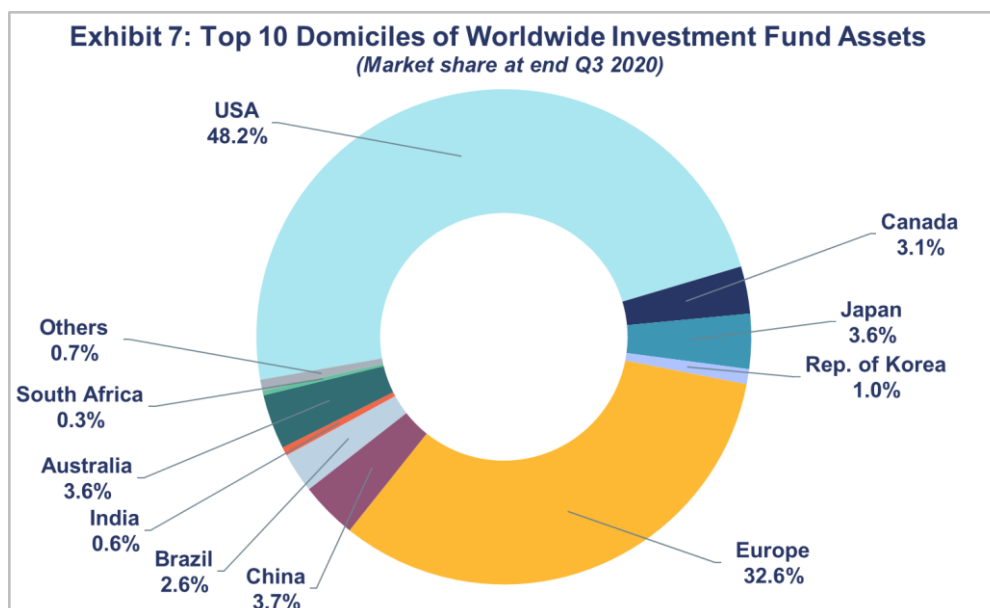

At the end of Q3 2020, 40.9 percent of worldwide regulated open-ended fund net assets were held in equity funds. The share of bond funds was 20.6 percent and the asset share of multi-asset funds was 16.9 percent. Money market fund assets represented 13.2 percent of the worldwide total.

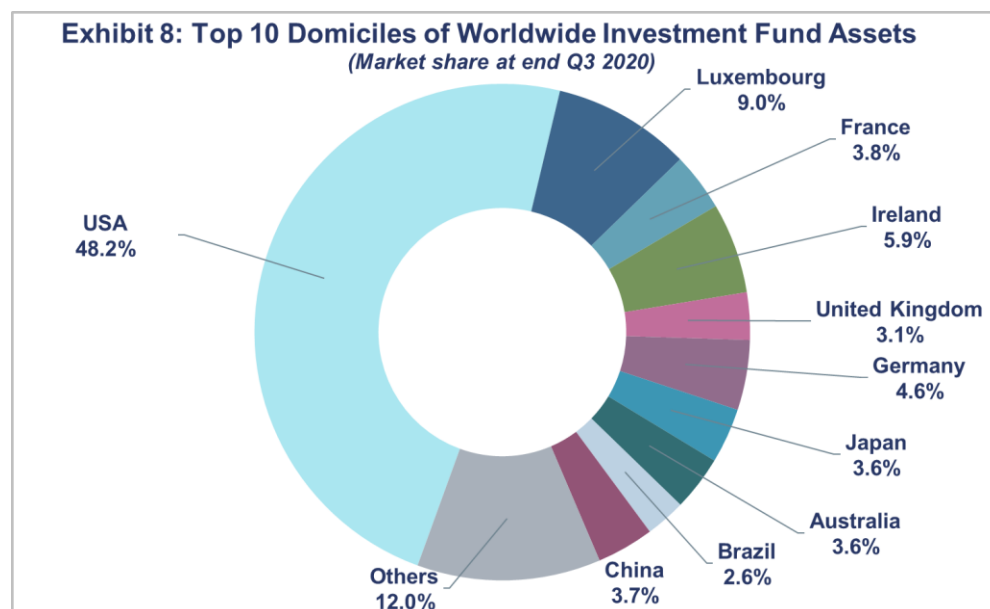

Looking at the worldwide distribution of investment fund net assets at end Q3 2020, the United States and Europe held the largest shares in the world market, with 48.2 percent and 32.6 percent, respectively. China (3.7%), Australia (3.6%), Japan (3.6%), Canada (3.1%), Brazil (2.6%), Rep. of Korea (1%), India (0.6%) and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 9 percent of worldwide investment fund assets), Ireland (5.9%), Germany (4.6%), France (3.8%), and the United Kingdom (3.1%).



Worldwide net sales of regulated open-ended funds decreased to EUR 244 billion in Q3 2020, from EUR 828 billion in Q2 2020. Long-term funds recorded net inflows of EUR 411 billion, up from EUR 387 billion in Q2 2020. Globally, equity funds recorded net outflows of EUR 24 billion, compared to net inflows of EUR 3 billion in Q2 2020. Bond funds registered net inflows of EUR 279 billion, compared to net inflows of EUR 280 billion in Q2 2020. Multi-asset funds worldwide increased from EUR 42 billion in Q2 2020 to EUR 100 billion in Q3 2020. Net sales of money market funds recorded net outflows of EUR 168 billion, compared to net inflows of EUR 441 billion in Q2 2020.

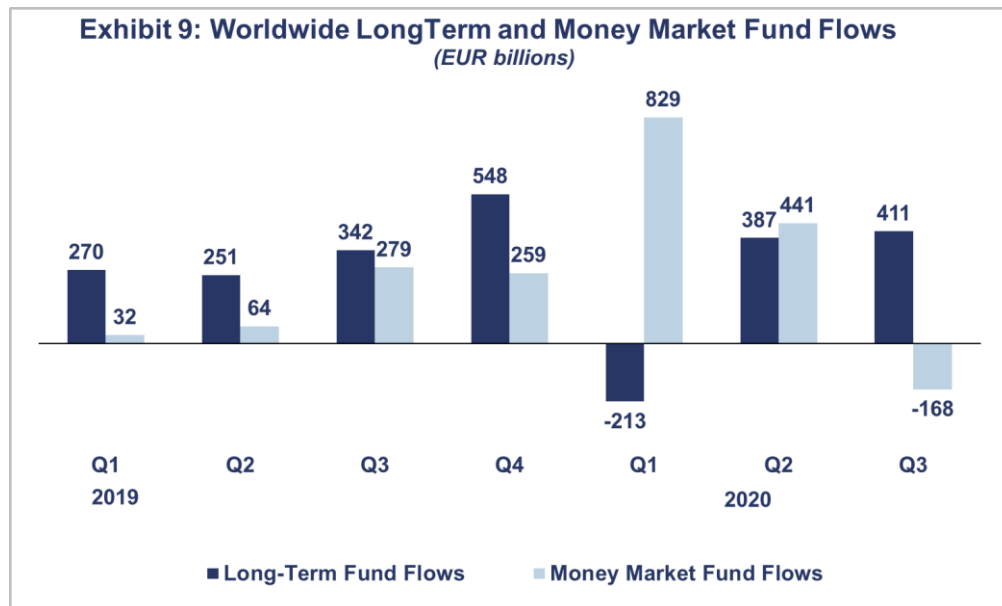

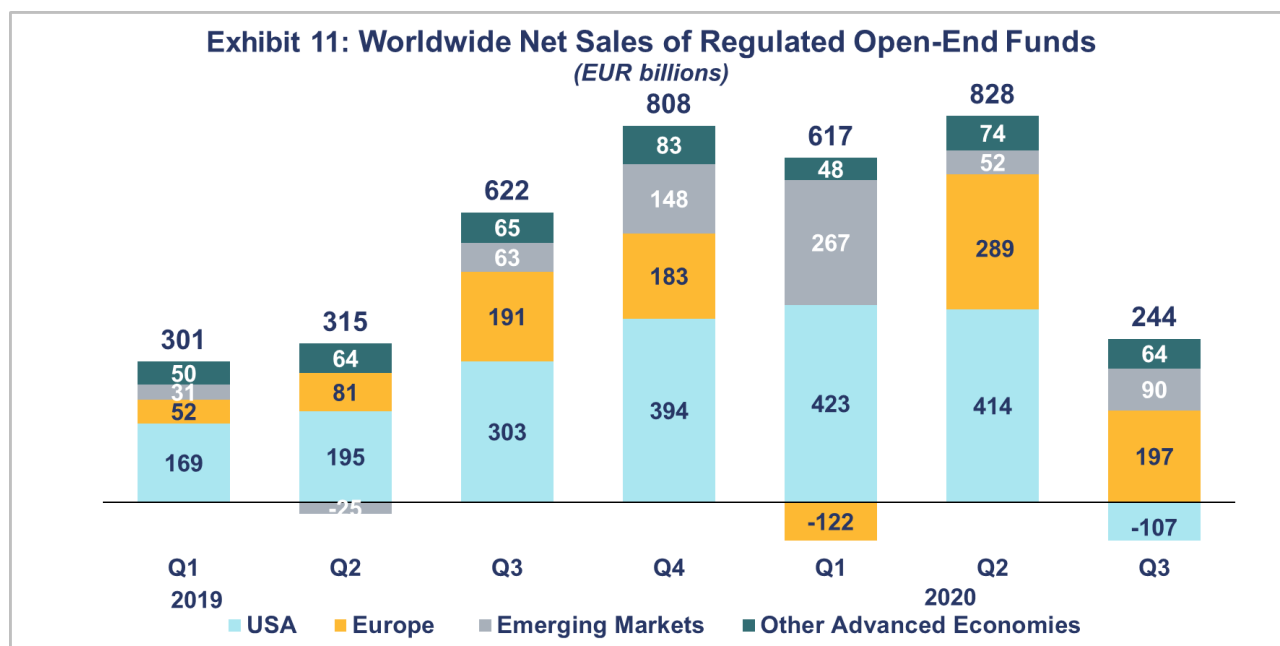

Net sales of regulated open-ended funds amounted to EUR 197 billion in Europe, mainly driven by net inflows in Luxembourg (EUR 52 billion), France (EUR 49 billion) and Ireland (EUR 36 billion).

The United States recorded net outflows of EUR 107 billion in the third quarter, mainly due to the strong net outflows from money market funds (EUR 197 billion) and equity funds (EUR 124 billion).

Emerging markets² recorded net inflows of EUR 90 billion (of which EUR 44 billion in China and EUR 30 billion in Brazil). Other advanced economies³ recorded net inflows of EUR 64 billion (of which EUR 38 billion in Japan and EUR 18 billion in Canada).



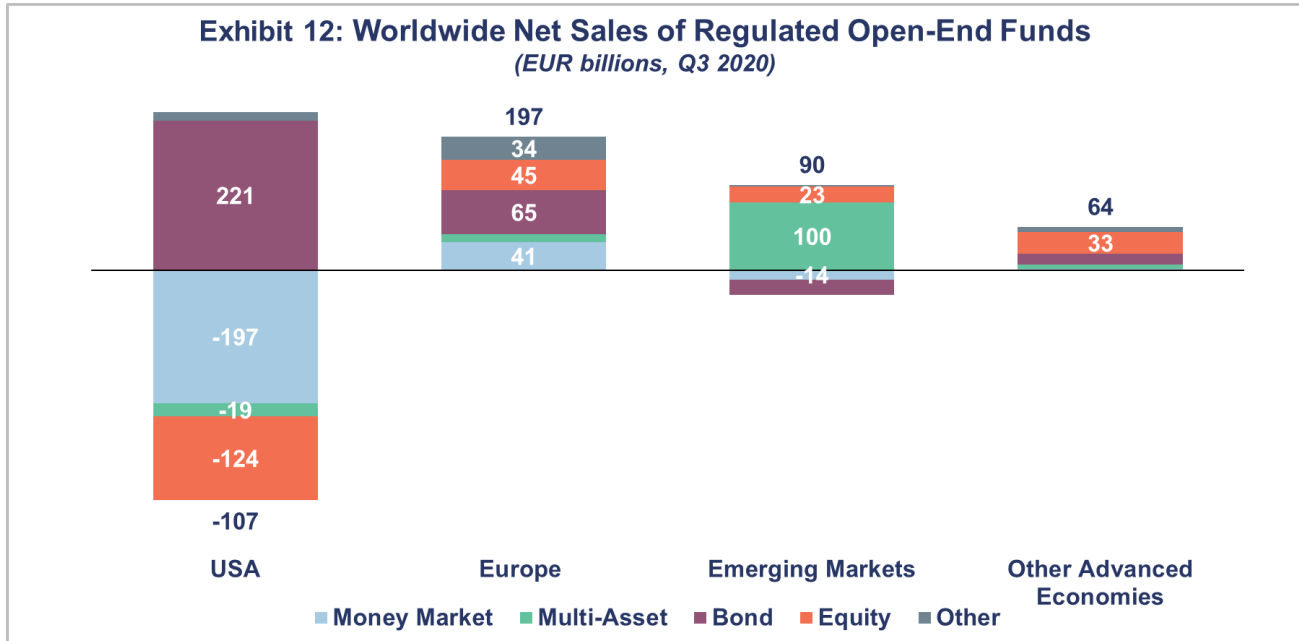
In Europe, long-term funds recorded net inflows of EUR 156 billion, compared to EUR 153 billion in Q2 2020. Net sales of equity funds increased from EUR 36 billion to EUR 45 billion in Q3 2020. Bond funds recorded net inflows of EUR 65 billion, down from EUR 72 billion in Q2 2020. Multi-asset funds registered net inflows of EUR 12 billion, compared to EUR 11 billion in Q2 2020. European money market funds recorded net inflows of EUR 41 billion, compared to EUR 136 billion in Q2 2020.

In the United States, long-term open-ended funds recorded net inflows of EUR 90 billion, down from EUR 145 billion in Q2 2020. Equity funds recorded net outflows of EUR 124 billion, compared to net outflows of EUR 74 billion in Q2 2020. Net sales of bond funds increased from EUR 195 billion to EUR 221 billion in Q3 2020. Multi-asset funds registered net outflows of EUR 19 billion, compared to net inflows of EUR 2 billion in Q2 2020.

² Emerging markets are countries thus defined by the International Monetary Fund. Data is not available for all emerging markets. The following countries are included: Argentina, Brazil, Chile, China, Costa Rica, India, Mexico, Pakistan, the Philippines and South Africa.

³ Other advanced economies are countries thus defined by the International Monetary Fund, based on criteria such as per capita income level and the degree of integration into the global financial system, excluding the US and the countries included in the Europe aggregate. Data is not available for all advanced economies. Other advanced economies include Australia, Canada, Japan, Korea, New Zealand and Chinese Taipei (Taiwan).

Money market funds in the United States recorded net outflows of EUR 197 billion, compared to net inflows of EUR 270 billion in Q2 2020.
