




Worldwide Regulated Open-ended Fund Assets and Flows

Trends in the Third Quarter of 2021



Brussels, December 14, 2021 – Worldwide regulated open-ended fund assets increased by 2 percent in euro terms to EUR 63.3 trillion in Q3 2021.¹ Worldwide net cash flow to all funds amounted to EUR 694 billion, compared to EUR 739 billion in Q2 2021.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Due to an appreciation of the US Dollar, worldwide investment fund net assets measured in U.S. dollars dropped to USD 73.3 trillion at the end of Q3 2021. This represented a decrease of 0.6 percent. The following two graphs compare the net asset growth in the seven largest countries/regions.



On a euro-denominated basis, worldwide equity fund assets increased by 1.8 percent to EUR 28 trillion at the end of Q3 2021. Bond fund assets increased by 3.3 percent to EUR 12.1 trillion. Multi-asset funds increased by 1.8 percent to EUR 10.8 trillion. Money market funds increased by 1.3 percent to end the quarter at EUR 7.3 trillion.




At the end of Q3 2021, 44.2 percent of worldwide regulated open-ended fund net assets were held in equity funds. The share of bond funds amounted to 19.1 percent and the asset share of multi-asset funds was 17 percent. Money market fund assets represented 11.5 percent of the worldwide total.

(by Type of Fund, 2021:Q3)**




Looking at the worldwide distribution of investment fund net assets at end Q3 2021, the United States and Europe held the largest shares in the world market, with 48.6 percent and 31.8 percent, respectively. China (4.4%), Australia (3.5%), Japan (3.3%), Canada (3.3%), Brazil (2.6%), Rep. of Korea (0.9%), India (0.7%) and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 8.8 percent of worldwide investment fund assets), Ireland (6%), Germany (4.2%), France (3.4%), and the United Kingdom (3.2%).



Net sales of worldwide regulated open-ended funds decreased to EUR 694 billion in Q3 2021, from EUR 739 EUR billion in Q2 2021. Long-term funds recorded net inflows of EUR 677 billion, up from EUR 673 billion in Q2 2021. Net sales of money market funds declined to EUR 18 billion, compared to EUR 66 billion in Q2 2021.



Globally, equity funds recorded net inflows of EUR 195 billion, compared to EUR 222 billion in Q2 2021. Bond funds registered net inflows of EUR 287 billion, up from EUR 252 billion in Q2 2021. Multi-asset funds increased from EUR 119 billion in Q2 2021 to EUR 163 billion in Q3 2021.



Net sales of regulated open-ended funds amounted to EUR 196 billion in Europe, mainly driven by net inflows in Luxembourg (EUR 88 billion), Ireland (EUR 51 billion) and Germany (EUR 32 billion).

The United States recorded net inflows of EUR 216 billion in Q3 2021, mainly due to the strong net inflows into bond funds (EUR 130 billion). The Asia-Pacific region² registered net inflows of EUR 171 billion (of which EUR 116 billion in China and EUR 28 billion in Japan). The Americas³ recorded net inflows of EUR 112 billion (of which EUR 65 billion in Brazil and EUR 38 billion in Canada).



In Europe, long-term funds recorded net inflows of EUR 206 billion, compared to EUR 251 billion in Q2 2021. Net sales of equity funds amounted to EUR 57 billion, compared to EUR 94 billion in Q2 2021. Bond funds recorded net inflows of EUR 67 billion, up from EUR 39 billion in Q2 2021. Multi-asset funds registered net inflows of EUR 75 billion, an increase compared to EUR 68 billion in Q2 2021.

European money market funds registered net outflows of EUR 10 billion, compared to net outflows of EUR 14 billion in Q2 2021.


In the United States, net inflows of long-term open-ended funds amounted to EUR 208 billion, down from EUR 259 billion in Q2 2021. Equity funds recorded net inflows of EUR 72 billion, compared to EUR 77 billion in Q2 2021. Net sales of bond funds decreased from EUR 167 billion in Q2 2021 to EUR 130 billion in Q3 2021. Multi-asset funds registered net inflows of EUR 10 billion, compared to EUR 11 billion in Q2 2021.

Money market funds in the United States recorded net inflows of EUR 7 billion, down from the net inflows of EUR 32 billion in Q2 2021.
