Highlights of Developments in Q1 2024

- UCITS and AIF net assets rose by 4.4% in Q1 2024. UCITS net assets increased by 5.3%, broadly in line with the stock market growth. AIFs saw a 2.7% increase in net assets.
- UCITS and AIFs attracted EUR 106 billion in net inflows in Q1 2024, compared to net inflows of EUR 142 billion in Q4 2023. Net sales of UCITS amounted to EUR 97 billion, up from EUR 91 billion in Q4 2023. AIFs registered net inflows of EUR 9 billion, compared to EUR 51 billion in Q4 2023.










- Long-term funds registered solid net inflows of EUR 85 billion, compared to EUR 21 billion in Q4 2023. Bond funds attracted very strong net inflows (EUR 95 billion), as investors flocked in these funds anticipating interest rate cuts. Equity fund net sales moved to positive territory, albeit to a low level (EUR 3 billion). Multi-asset funds continued to experience net outflows totalling EUR 15 billion, though this marked a slowdown compared to EUR 46 billion of net outflows in Q4 2023.
- Money market fund net sales slowed down. Net inflows into money market funds amounted to EUR 21 billion, compared to EUR 121 billion in Q4 2023.



- Net outflows from SFDR Article 9 funds continued but net sales of long-term (LT) Article 8 funds turned positive again. Net outflows from LT Article 9 funds amounted to EUR 4.1 billion, compared to EUR 3.5 billion in Q4 2023. LT Article 8 funds attracted net inflows of EUR 19 billion, compared to net outflows of EUR 27.1 billion in Q4 2023.
- Fund acquisitions by European retail investors were negative in Q4 2023 (EUR 10 billion), but most types of institutional investors, in particular insurers and pension funds, increased their fund acquisitions.






Net Sales of UCITS by Investment Type















The European Investment Fund Industry Net Sales of AIFs by Investment Type



The European Investment Fund Industry Net Assets of UCITS and AIFs by Investment Type








The European Investment Fund Industry Net Sales of SFDR Article 8 and 9 UCITS²







