Highlights Q3 2019

- **Total net assets of UCITS and AIFs grew by 3.8 percent to EUR 17.2 trillion.** This solid rise in net fund assets was driven by an increase in the market value of bonds and stocks.
- **UCITS and AIFs recorded net sales of EUR 190 billion,** the highest quarterly sales since Q1 2018. UCITS accounted for the largest part of the net sales (EUR 157 billion), up from EUR 39 billion in Q2 2019. Net sales of AIFs amounted to EUR 33 billion, down from EUR 48 billion in Q2 2019.










- **The bond fund rally continued.** European bond funds attracted EUR 81 billion, accounting for 42 percent of total net sales of funds in Q3 2019. This evolution can be explained by the shift towards a more accommodative monetary policies, which took place in 2019 on both sides of the Atlantic, and the market's assessment that this stance would be necessary for a prolonged period of time.
- **Net outflows from equity funds slowed down.** Persistent downside risks related to trade policies and geopolitical factors continued to weigh on demand for equity funds. However, the level of net outflows decreased relative to Q2 2019, pointing to a certain increase in confidence in the recovery of future economic growth against the backdrop of strong monetary stimulus.
- **Demand for money market funds significantly strengthened.** Net inflows into money market funds reached EUR 73 billion. This suggests that there are investors who are waiting for a lessening of the uncertainties before investing more in long-term funds.

Net Sales of UCITS by Investment Type














Net Sales of AIFs by Investment Type ²


Net Assets of UCITS and AIFs by Investment Type ³





Ownership of Investment Funds in Europe ⁴


Investment Fund Ownership by Type of Investor
(EUR billions and share of total, end Q2 2019)




Investment Fund Ownership by Country
