



Highlights of Developments in Q3 2020

- Net assets of UCITS and AIFs grew by 2.8 percent in Q3 2020 to EUR 17.58 trillion.** UCITS net assets increased by 3.1%, whereas the net assets of AIFs grew by 2.4%. These growth rates were broadly in line with growth in global stock and bond markets. At the end of September 2020, net assets of UCITS and AIFs were still 0.9% smaller than at the end of 2019, due to the steep markets' drop in March 2020.
- UCITS and AIFs attracted EUR 195 billion of net inflows in Q3 2020.** Net sales of UCITS amounted to EUR 145 billion, compared to EUR 272 billion in Q2 2020. AIFs attracted EUR 51 billion in net new money over the quarter, up from EUR 12 billion in Q2 2020.










- Net inflows remained robust across all categories of long-term funds.** Net sales of bond and other funds in Q3 2020 declined slightly compared to the previous quarter. Net inflows into equity funds on the other hand increased, as investors remained relatively optimistic about the outlook for financial markets.
- Money market funds (MMFs) saw a sharp decline in net sales, from EUR 136 billion in Q2 2020 to EUR 41 billion.** This is, however, still a high level, which indicates a certain degree of caution on the part of investors at a time of financial uncertainty.



- After having sold investment funds for a net amount of EUR 88 billion in Q1 2020, European investors came back to the market to purchase a net amount of EUR 148 billion in Q2 2020 (see charts on page 5).** All main types of investors increased their purchases of funds, including households who invested a net amount of EUR 32 billion in Q2 2020, a record not seen since Q2 2017.

Net Sales of UCITS by Investment Type







Net Sales of AIFs by Investment Type²


